OPENING OF CONFERENCE

Mr. Chairman, Ladies and Gentlemen. Quebec's demand for oil extracted from sources like rapeseed is equivalent to around 1,500,000 bushels, or in other words the crop from at least 50,000 acres. It is up to you. Gentlemen, within the scope of this Congress, to see to it that this field of action, remains unlimited, and that there will be many new opportunities in marketing, new ways of producing and processing rapeseed so that in the coming years the consumers will use more and more of the products. I think that this Congress, will bring new developments which could for many reasons influence the orientation of Quebec's agriculture.

I would like to express my full appreciation particularly to the sponsors of this Congress, the Department of Industry, Trade & Commerce of the Federal Government and to the Rapeseed Association of Canada and wish to all of you, Ladies and Gentlemen, fruitful deliberations all through this Congress and a very enjoyable Séjour in La Belle Province. I invite you to visit Quebec City, and it will be my pleasure to receive you in my office at the Parliament Buildings.
